Sugar Grove HOA Pool Rules

The following rules are designed to help make the Sugar Grove Farms Community swimming pool a safe and healthy place for recreation. Please abide by the following POOL RULES when using the pool:

POOL AND AMENITIES CENTER ARE UNDER 24 HOUR SURVEILLANCE.

- 1. Pool hours are from 9 a.m. to 10 p.m. daily. The pool will be accessible by electronic key card only for residents in good standing with the Association. Individual(s) who are on the premises without a resident or who are under age and without a guardian should be/can be asked to leave the premises by any HOA member.
- 2. Children under 14 years of age and non-swimmers shall not use the pool unless accompanied by a responsible adult (age 18 or over). Children under the care of baby sitters under age 18 shall not enter the pool area. **NO SWIMMING ALONE**.
- 3. Always shower before using the pool (required by the Indiana State Board of Health). A bather leaving the pool to use the toilet shall take another cleansing shower before returning to the pool enclosure.
- 4. Anyone who has an area of exposed sub-epidermal tissue, open blisters, cuts, etc. is advised not to use the pool. Anyone who has had diarrhea in the past (2) weeks shall not use the pool.
- 5. Street clothes are not allowed in the pool.
- 6. No running, rough play, obscene language, or dangerous/offensive behavior is permitted in the pool, on the runways, or in the dressing rooms and should be reported to M-Group (our management company) at 317-207-4281. The pool is for community enjoyment, so please be respectful of other members by keeping volume of personal iPods, radios, or other listening devices to a minimum.
- 7. Spitting, spouting of water, blowing the nose and similar behavior in the pool is prohibited.
- 8. Diving from the side of the pool is not permitted at any time.
- 9. Guests must be accompanied at all times by an adult resident (age 18 or over). When the resident leaves, the guest(s) must also leave. Residents are responsible for all actions of their guests.
- 10. Under no circumstances will alcohol, tobacco, firearms or drugs be permitted in or around the amenity center or pool. Anyone seen engaging in the use of these things will be subject to loss of privileges to use the amenity center and pool.
- 11. No glass containers of any type are allowed in the pool area.
- 12. All trash generated by visitors must be placed in garbage containers or otherwise properly disposed of. Food is not permitted within 8 feet of the pool's edge.

- 13. Children who are not toilet-trained will be allowed in the pool only if they wear a swim diaper and swim suit. Do not change swim diapers pool side.
- 14. Incidents of fecal activity in the pool shall be reported immediately to M-Group at 317-207-4281 or the Hendricks County Health Department 317.745.9217 so that immediate chlorinating can begin to reduce pool closure time. The pool will remain closed a minimum of 24 hours after a fecal accident is reported.
- 15. No pets are allowed in the fenced pool deck area or in the pools themselves.
- 16. The restroom fixtures are sanitized and cleaned on a regular basis. The designated maintenance person(s) are responsible for cleaning mirrors, counters, stocking hand towels, and emptying trash. However, please be mindful of other HOA members by cleaning up after yourself when using the restrooms and amenity center. Report any problems or damage to M-Group at 317-207-4281.

Contact the Plainfield Fire Department 317.839.6939 of any mechanical malfunction of pool equipment.
